4. Entire copy of passport.
5. Copy of I-94 card, front and back.
6. Current employment letter.
7. Tax returns for 3 years.
8. Affidavit of support duly notarized (Form I-864) if you are applying for your family.
9. Medical forms (to obtain a list of INS designated doctors and medical forms please call 1-800-375-5283).
10. Photographs (should be photographed in accordance with INS specifications).
